  2. A **Use Permit** to allow a trucking terminal yard, contractor's storage yard, building materials sales yard, heavy equipment storage, a heavy equipment tire sales and repair yard, a concrete and asphalt recycling facility, a metal sorting and storage yard, and a greenwaste facility on an approximately 50-acre-site in the IR(SM) zone.
