

EMERGENCY TEMPORARY USE OF PROPERTY USE PERMIT

APPLICATION GUIDE AND INSTRUCTIONS

AN ENTITLEMENT SUBJECT TO APPROVAL BY THE PLANNING DIRECTOR OR BOARD OF SUPERVISORS

OVERVIEW

A Temporary Use Permit for Emergency Temporary Use of Property may be authorized/granted pursuant to Sacramento County Zoning Code Section 3.10.3.K.

Should the Governor of California declare a State of Emergency or the County Board of Supervisors declare a Local Emergency, the Planning Director may issue a Temporary Use Permit for Emergency Temporary Use of Property if the Planning Director can make the following findings:

- The proposed use of the property is to support emergency response efforts or the proposed use of the property will mitigate impacts of an emergency;
- The proposed use of the property is permitted within the zoning district and will not conflict with applicable Community Plan or General Plan policies or designations;
- The proposed use meets the general requirements of Section 3.10.2, as applicable.

Pursuant to Section 3.10.3.K.2, if the Planning Director cannot make the findings listed above, the Board of Supervisors may determine that an overriding public interest exists and may commit the temporary use of the property.

Emergency Temporary Use Permits may be conditioned to ensure minimal impacts to the subject property or to surrounding properties. An Emergency Temporary Use Permit does not release an applicant from the requirement to obtain all necessary site improvements and building permit approvals. The Emergency Temporary Use Permit has a limit of a maximum of one year with the opportunity for the applicant to apply for an extension of up to one additional year.

FEES

An Emergency Temporary Use of Property Use Permit has an application deposit fee of **\$495.33**. After review of the project application, if it is determined that the Planning Director cannot make the necessary findings and that the Board of Supervisors must make the overriding public interest determination to grant the temporary use permit, then additional fees will be required.

Applications that are pre-determined to require a determination by the Board of Supervisors shall submit a deposit of **\$2,679.38**.

SUBMITTAL REQUIREMENTS

The application form and submittal options/procedures (such as online submittals) can be found on our website www.planning.saccounty.net.

Below is a list of the required application submittal materials.

1. Completed Emergency Temporary Use of Property Application Form.
2. Signed statement by property owner granting permission to use the site. This statement must be signed by the property owner or by the lessee. In the case where a lessee is granting permission, a copy of the lease must accompany this application. Dates of period of time for which the permission is granted must be specified.
3. Site plan delineating the limits of the proposed Temporary Use. The Site Plan shall contain the minimum components:
 - North Arrow
 - Address and/or APN of the property (properties) where the temporary use will be conducted.
 - All existing development
 - Proposed location(s) for requested use
 - All proposed development or improvements to property for proposed temporary emergency uses
4. If on-line submittal is not used, a digital copy of all submittal documents must be provided on a CD/Flash Drive at the time of application submittal.
